## Windemere Homeowners Association Trustee Meeting Minutes, November 20, 2017

Present: Ron Simmons and Ron O'Rear.

Meeting Minutes: The Meeting Minutes from the October 19, 2017, Trustee Meeting

were approved.

Treasurer Report: As of November 20, 2017, there is a balance of \$3,523.11 in the

checking account.

Budget vs. Actual: We are \$1,117.85 over budget for the year. The main contributors to

the overage include the unplanned Attorney fee (\$170.00), the unplanned irrigation system backflow valve replacement (\$390.00), additional irrigation system sprinkler replacement cost (\$23.50), additional CCN mulching and trimming cost (\$261.54), additional CCN mowing and weeding cost (\$137.15), unplanned purchase of a Windemere ink stamp for check deposits (\$25.61), and unplanned secretarial cost for the special meeting announcement (\$110.05).

Plan Review Committee: A homeowner's application for installation of a standard aluminum

fence was approved.

Neighborhood Directory: A new Neighborhood Directory was distributed to the homeowners.

Pine Tree Removal: The cost estimate for removing the dying pine tree on the north side

of the Abbey Lane entrance was \$250.00 to cut the tree and haul away the debris. The estimate for removing the stump is \$250.00.

Pear Tree Trimming: The Bradford Pear trees along Windemere Way will be reassessed

next year to determine if they require trimming. The Horticulturist who last trimmed the trees recommended not trimming the trees yet.

Draft 2018 Budget: The Trustees reviewed the draft 2018 budget. The 2018 budget will

be finalized the first week of December 2017 and distributed with

the Annual Fee Notification Letters.

Annual Fee Amount: The Trustees established the annual fee amount for the Windemere

homeowners for 2018 at \$150.00.

Homeowners: The notification letters to the Windemere homeowners will be

mailed the second week of December 2017.

Annual Meeting: The Windemere HOA Annual Meeting will be held on Sunday,

January 7, 2018 at 2:00pm at Ron and Bonnie Simmons' house.

Replacement Trustee: Barb Skusa resigned as temporary Trustee due to medical issues.

The Trustees will solicit a volunteer to replace Barb and run for the

open Trustee position in the 2018 elections.
