1. Opening

3. Financial Report

- Ron O'Rear will finalize the financial documents that will be shared at the annual meeting when 2024 transaction activity has been completed.
- Ron O'Rear introduced a working copy of the 2024 Year In Review document that will be shared at the annual meeting.
- Bob Gardner will review the 2024 minutes to identify any highlights that should be included in the Year in Review document and share with Ron O'Rear for possible inclusion.
- Thus far, we've received two nominations for the position that will be vacated at year-end 2024.
- Bob Gardner will prepare and distribute ballots to the community 3 weeks prior to the annual meeting.
