1. Opening

2. Meeting Minutes

3. Financial Report

- Ron O'Rear reviewed the financial reports for the period ending 11/30/25. Key budget performance indicators are summarized below:

- The documents to be shared during the meeting were reviewed.
- Bob provided a summary of key topics and issues addressed during 2025 to support Raghu's annual review discussion during the annual meeting.
